Reston, Va. - The ACRM | American Congress of Rehabilitation Medicine announces that effective 1 May 2013, Helen Hoenig, MD, MPH was appointed Deputy Editor of its journal, the Archives of Physical Medicine and Rehabilitation.

Dr. Hoenig is Chief of Physical Medicine & Rehabilitation Service at the Veterans Affairs Medical Center in Durham, NC, and Professor in the Department of Medicine/Geriatrics at Duke University Medical Center.

As Deputy Editor, Dr. Hoenig will support Leighton Chan, MD, MPH, and Allen W. Heinemann, PhD, ABPP, Co-Editors-in-Chief of Archives, to carry out the mission and strategic development of the journal.

Speaking on behalf of both Co-Editors-in-Chief, Dr Heinemann said, "I'm delighted that Dr. Hoenig has agreed to accept the position of Deputy Editor for Archives. I have enjoyed working with her over the past several years, and have come to appreciate the experience and wisdom she brings to editorial decisions. It will be a real pleasure to work with her more closely in assuring that we fulfill the mission of Archives: to disseminate original information, with the goal of advancing the art and science of interdisciplinary rehabilitation, thus improving the health and welfare of persons with chronic illness and disabilities and reducing the cost of care."

Dr. Hoenig's research examines the effect of different ways to compensate for physical limitations and how to best provide rehabilitation services, with a focus on assistive technologies and tele-technologies. She has authored more than 76 peer-reviewed articles, and 13 book chapters (including an UpToDate Topic).
